NARRAT IVE NOVEMBER 1944

Ol November 1944

During early part of period, 3rd Bn, 142nd Inf, relieved by 2nd Bn, 142nd Inf, and closed in LEPANCES at 0315A hours. Elements 141 RCT moved to position vic V-334593, 2nd Bn, 442 RCT to position vic V-318605, preparatory to attack at 0930A hours. 143 RCT reported 2nd Bn positions vic V-316580 and V-320575. At 1000A hours 2nd Bn, 141 RCT and 2nd Bn, 442 RCT, reported SA and mortar opposition after crossing LD. 2nd Bn, 143 RCT, crossed LD at 1020A hours and at 1140A hours had reached V-319580 and V-319581 without opposition. At 1300A hours, 141 RCT reported 2nd Bn, 141 RCT, and 2nd Bn, 442 RCT, organizing positions around sector vic V-334594 and V-334597. 100th Bn, 442 RCT, held ground vic V-339568 with 3rd Bn, 442 RCT, in positions vic V-350573 and V-354564. Enemy resistance continued stubborn along slopes above LA HOUSSIERE. At 1330A hours, 2nd Bn, 143 RCT, reported objective taken with out opposition, in positions vic V-320577 and V-327581. At 1300A hours, 3rd Bn, 141 RCT, launched attack against enemy positions vic V-340584 to V338586 and met fierce resistance from estimated 50-60 enemy in dug-in positions. At 1600A hours, elements 2nd Bn, 141 RCT, and 2nd Bn, 442 RCT, reported hill mass vic V-335598 captured, with lines extending to vic V-337598. Co F, 442 RCT. reported enemy contact on Hill 609 (V-337603). By 1800A hours, 2nd Bn, 141 RCT and 2nd Bn, 142 RCT, had completed clearing of hill mass vic V-335598 with enemy contact still reported on Hill 609. 3rd Bn, 141 RCT, prepared to resume attack. 143 RCT had secured hill vic V-320577. By end of period, Co F, 442 RCT, reduced enemy resistance on Hill 609 and 3rd Bn, 442 RCT, reported no progress against heavy enemy resistance in sector. TERRAIN: Forests, mountains, difficult. Roads poor.

02 November 1944

Inter-regimental reliefs effected in sectors during night. Little enemy activity reported during night 01-02 November. By 12004 hours 100th Rn and 3rd Bn. 442 RCT, were working towards lower slopes of hill mass above LA HOUSSIERES against scattered enemy infantry detachments. 2nd Bn, 141st RCT cleared ridge from N to S vic V-330577 without opposition and relieved by 3rd Bn, 142 RCT. At 1400A hours, 442 RCT reported no enemy contact as elements pushed slowly S down the LA HOUSSIERE ridges. 2nd Bn, 442 RCT, moved without contact to vic V-342593 and V-335597. At 1600A hour 3rd Bn, 141 RCT, reported enemy contact vic V-351578. At 1800A hours, 442 RCT reported 2nd Bn receiving Sa fire along nose of hill V-342590, as 3rd Bn advanced against scattered SA resistance vic V-3356. At 2100A hours, 2nd Bn, 141 RCT, was effecting relief of elements 7th Inf in sector, prepared to continue advance to SE against enemy roadblock. 2nd Bn, 142 RCT, relieved by 1st Bn, 141 RCT, at 2100A hours.

03 November 1944

During night 02-03 November, elements 141 RCT relieved elements 7th Inf in N op Div sector. 2nd Bn, 442 RCT, reported heavy arty and mortar fire vic V-333593. At 12004 hours, 3rd Bn, 141 RCT, preparing to relieve positions of 2nd Bn, 442 RCT. Enemy strongpoints were reported at V-340583, V-348615, and V-354580. 442 RCT reported enemy opposition vic V-363565, V-353562 and V-344563. By 16304 hours, elements 2nd Bn, 143 RCT, had completed relief of 3rd Bn, 142 RCT, in sector. At the same time, 3rd Bn, 442 RCT, in vic V-350564, reported small scale enemy counterattack from the S. 141 RCT reported the following locations: 3rd Bn vic V-338593, V-334597; 2nd Bn V-338608, V-338615 and V-347618, with enemy positions reported to front. 143 RCT reported positions organized around nose of hill vic V-3258 to V-325580 to V-331575. Little change in dispositions during balance of period. TERMAIN: Mountainous, forests.

04 November 1944

During early part of period, 142 RCT reported patrol contact vic V-261486; and 143 RCT patrolled aggressively from LES POULIERRES and BIFFONTAINE. Elements 141 RCT in southern sector, operating as part of STACK FORCE, maintained contact with French throughout period. Elements 442 RCT continued slow advance to clear hill mass above LA HOUSSIERES (3556), some local advances being made, although enemy delaying detachments reacted strongly to attempts to cut road vic LA HOUSSIERES.

05 November 1944

During period southern part of sector remained relatively quiet, patrol contact maintained with French vic LETHOLY. In the northern sector, 442 RCT continued holding action and local advances on ridges above LA HOUSSIERES; 142 RCT continued push S and SE down VANEMONT valley to relieve enemy pressure in LA HOUSSIERES sector. At 1000A hours, 142 RCT had occupied Hill 699 (V-347616) against SA opposition, with other elements advancing to V-337603 without opposition. Enemy roadblock vic V-341608 held up advance in central sector. At 1630A hours 2nd Bn, 142 RCT, reported in contact vic V-342605 as 3rd Bn advanced without contact to vic V-348608. Little change reported during balance of period.

06 November 1944

Little change reported during night 05-06 November. 232nd Engr Co of 442 RCT relieved 100th Bn, 442 RCT, in position. 141 RCT continued assembling of elements in LEPANGES area as advance of 142 RCT pinched out their sector. 2nd Bn, 142 RCT, occupied enemy roadblock sector during morning without opposition—enemy having withdrawn during night. 142 RCT continued the pursuit to the S and E. At 1245A hours, 3rd Bn, 142 RCT, reported in fire fight vic V-356600, and at 1830A hours had advanced to vic V-352563, making slow progress. 2nd Bn, 142 RCT, was held up vic V-347564—enemy opposition to 442 RCT continued stubborn along LA HOUSSIERES slopes. At end of period, 142 RCT reported 2nd Bn positions vic V-348597, V-344597, with 3rd Bn vic V-354597, V-358597.

07 November 1944

STACK FORCE (1st Bn, 141 RCT, 1st Bn, 142 RCT and 1st Bn, 143 RCT) maintained contact with French vic V-251422 and V-246419 throughout period without incident. 142 RCT from vic V-358598 and V-348598 attacked to SE down La ROUGES EAUX valley towards VANEMONT at 0800A and at 1000A hours reported advance without opposition. 442 RCT continued local attacks to clear slopes above LA HOUSSIERE, encountered SA and mortar fire, as enemy reacted strongly to attempts to push towards rad and RR E - W from LA HOUSSIERE. By 1200A hours, 2nd Bn of 142 RCT was on objective V-353-583 and 3rd Bn was in fire fight at V-358593. At the same time 3rd Bn, 141 RCT (only element of RCT in the line), swept ridge to right of 142 RCT sector and established contact with 442 RCT. 3rd Bn, 141 RCT assembled at LE PANGES. At 1600A hours, 2nd Bn, 142 RCT, continued advance SE from vic V-353581. 3rd Bn, 142 RCT, on objective at V-367583. 442 RCT reached objective vic V-367583 and V-359580 after slow advance in difficult terrain. Little change in dispositions noted throughout balance of period.

08 November 1944


142 RCT encountered enemy MG fire vic V-361576 as 2nd En continued advance at 0800A hours. 442 RCT(less 100th En in BRUYERES) fought strong German resistance in their sector above LA HOUSSIERE throughout period, as 142 RCT continued steady advance towards VANEMONT to relieve the pressure in the LA HOUSSIERE (V-3456) sector. 1st En, 142 RCT began relief of elements 442 RCT at 1430A hours. At end of period 142 RCT, working over difficult terrain, and against enemy MG strongpoints, reached positions vic V-358566, V-362576, V-366582 and V-360597.

09 November 1944

142 RCT continued attack at 0800A hours, met enemy resistance after 200 yards advance, as small fire fights sprang up all along line. 1st Bn, 142 RCT, completed relief elements 442 RCT and 2nd Bn, 442 RCT, assembled vic FAYS; 3rd Bn, 442 RCT, assembled vic LE PANGES. 142 RCT continued advance throughout morning, reduced enemy resistance at RJ V-363578 and reached vic V-364565, as 3rd Bn encountered enemy dug-in positions at V-367568. Enemy arty activity increased during mid-period, and heavy arty and mortar concentrations forced slight withdrawal of Co F, 142 RCT, vic V-362565. At 1600A hours, 1st Bn, 142 RCT, was attacked by estimated 50 enemy from vic LA HOUSSIERE —attack repulsed without loss of ground. Second enemy counterattack thrown back vic V-364566 and advance of 2nd Bn continued. Little change reported in dispositions during balance of period.

10 November 1944

Little change reported in southern sector; 143 RCT continued aggressive patroling in BIFFONTAINE - LE POULLIEME sector. 142 RCT continued attack with three Bns at 0900A hours. 1st Bn continued sweeping slopes to road - RR vic LA HOUSSIERE; 3rd Bn moved SE toward vic V-369574; 2nd Bn moved along VANEMONT valley and slopes to the W. At 1200A hours all elements were advancing without contact, as 1st Bn

cleared road running west from LA HOUSSIERE and entered outskirts of town, and 2nd Bn moved to V-362561 and advanced towards V-367568. By 1600A hours, 2nd Bn occupied VANEMONT without contact, elements 1st Bn moved through LA HOUSSIERE against no resistance. No change reported in dispositions during balance of period as patrol elements of 142 RCT pushed through LA HOUSSIERE to the S.

11 November 1944

Little activity in southern and central sectors during period. 142 RCT continued mop-up of IA HOUSSIERE sector. Engrs cleared BIFFONTAINE - LA HOUSSIERE - VANEMONT - LA ROUGE EAUX road. In STACK FORCE sector, 1st Bn, 143 RCT, attacked Hill 701 (V-2649) at 1000A hours and encountered scattered SA resistance, general sector reported heavily mined. By nightfall 1st Bn, 143 RCT, reported on Hill 701 in positions vic V-272498, V-275502. 142 RCT continued push by infiltration toward hill mass vic V-3354.

12 November 1944

142 RCT continued occupation of hill mass MT THIRVILIE (V-3354). 143 RCT started advance towards IE CEUR MT, elements 3rd Bn, 143 RCT, pushed into AUMONTZED against SA opposition. Some resistance encountered vic V-299540. Co "C", 142 RCT, engaged enemy in hand to hand fight vic V-342548 at about 1030A hours and repulsed local attacks without loss of ground. 143 RCT continued working from LA CHAPELIE towards Hill 703 (V-2953) and woods vic V-292536. By early afternoon elements 2nd Bn, 143 RCT, reported on slopes IE CLUR MT at V-318560 without opposition. 3rd Bn reported fire fight vic V-292535 and V-297540. Co I secured AUMONTZEY after short fight. Elements 142 RCT reached objective at V-335548 during latter part of period. 143 RCT continued mop-up of IE CLUR MT.

13 November 1944

442 RCT moved from assembly area to relieve elements 142 RCT in sector. Balance 142 RCT continued clean-up of MT THIRVILLE sector and relief of elements 142 RCT completed by 442 RCT at 1600A hours. 143 RCT continued consolidation of positions vic AUMONTZEY and LE CLUR MT.

14 November 1944

lst Bn, 142 RCT, pushed to objective vic V-322525 and V-330525. 141 RCT secured objectives Hill 734 (V-286474) and (V-277455). 143 RCT reported elements along ridge at V-285483 and at V-297514 and V-304518. 442 RCT, with one Bn, held defensive positions along W slopes VANEMONT valley and blocked to the E and NE. By midday, 143 RCT reported elements in IVOUX-142 RCT reported NEUNE cleared—enemy withdrawal from GRANGES reported. At 1500A hours, 143 RCT reported elements on objectives at V-305503, V-293492, V-292482 and in town of GRANGES. 141 RCT continued advance from V-267452 and V-263442. In southern sector, elements 141 RCT pushed patrols to LE THOLY highway without contact. Little change in dispositions reported for balance of period.

15 November 1944

142 RCT completed inter-regimental reliefs vic THIRVILLE and LA HOUSSIERE as elements continued push to E and SE. 143 RCT continued local engagements in IE CEUR MT Sector with some enemy detachments still holding out on Hill 703. Relief started during latter part of period of elements 143 RCT. 2nd Bn, 143 RCT, assembled in FAYS at 1500A hours. Elements 442 RCT moved back in line for attack at 0900A thru elements 103rd Inf Div to secure high ground vic V-374588. No reports on progress of 442 RCT during balance of period.

16 November 1944

During early part of period elements 142 RCT occupied RENNEGOUTTE (V-342523). 442 RCT continued blocking mission on E flank and maintained contact with 409th Inf. 141 and 142 RCT's continued advance to SE against light opposition.

17 November 1944

During early part of period, 142 RCT reported house-to-house fight in MARIE-MONT (V-3450) as other elements of RCT continued local advances in road net towards GERARDMER. 442 RCT ordered relieved without delay; moved 3rd Bn to vic BRUYERES; 2nd Bn relieved by elements 143 RCT. At 1430A hours, 2nd Bn, 142 RCT, reported on objectives vic V-337507, 334499, with combat patrols enroute to BARBEY-SEROUX. CO, 2nd Bn, 143 RCT, took command 442 RCT sector at 1600A hours. 142 RCT continued mop-up of MARIEMONT (V-3450) and pushed elements into BARBEY-SEROUX (V-3349) without opposition. Elements 141 RCT reached objective at V-311458, as other elements moved towards objective at V-310465. BARBEY-SEROUX cleared by 142 RCT during latter part of period and patrols pushed to CORCLEUX (V-3653), as 141 RCT pushed elements into town of LIEZEY.

18 November 1944


MARIEMONT reported clear by 142 RCT during early part of period, and patrols to CORCIEUX (V-3552) reported town clear of enemy. Elements 141 RCT continued push towards GERARDMER from direction GRANGES. 442 RCT closed in DOCELLES and passed to Army control. 142 RCT occupied CORCIEUX (V-3653) during afternoon, and 143 RCT moved towards objectives overlooking & LEONARD and ANOULD.

19 November 1944

142 RCT continued push generally to a towards GARBEPAL; 141 RCT continued clearing of roads N, NW GARARDMER. By mid-period, 143 RCT reported elements past SARUPT (V-4056), on way towards Hill 516, and elements on objectives vic V-398562 and V-397540, with elements vic V-396540 and V-389535. At end of period, 142 RCT reported elements at V-346480, V-353495 and V-393497.

20 November 1944

143 RCT continued advances to E from hill mass overlooking ANOUID, ST LEONARD and IE SOUCHE. 141 RCT moved elements up GERARDMER - GERBEPAL road for contact with 142 RCT elements moving E through GERBEPAL. 143 RCT reported elements in ST LEONARD - ANOULD and sector along the river - enemy detachments continued to hold out on high ground E of river. 142 RCT cleared GERBEPAL.

21 November 1944

143 RCT continued mop-up of ST LEONARD - LE SOUCHE - NOULD sector. 141 RCT moved to high ground overlooking the river W of CLEFCY - PLAINFAING.

22 November 1944

143 RCT occupied high ground E of La SOUCHE and W slopes of Hill at V-443503. 141 RCT pushed elements across river to hill mass vic V-443535, but were forced to withdraw to vic CLEFCY in face of heavy enemy S. and mortar fire. Little change in 142 RCT situation.

23 November 1944

141 RCT continued push from vic CLEFCY toward high ground overlooking PLAIN-FAING. 143 RCT cleared VANCHERES and reached edge of woods vic V-434552, pushed patrols towards MANDRAY. During late afternoon, 1st Bn, 142 RCT moved by truck from vic SARUPT to MANDRAY, thence on foot toward BAN DE LAVELINE. The Bn became engaged by strong enemy road block vic V-477563 and was held up during balance of period.

24 November 1944

During early part of period 141 RCT was engaged by enemy elements vic FRAIZE.

142 RCT had elements in contact with enemy road block V-477563 and other elements

- after overcoming enemy opposition at LA CROIX - pushed toward BAN DE LAVELINE.

1st Bn, 142 RCT reached BAN DE LAVELINE in mid-afternoon - secured town with little resistance. 1st Bn, 143 RCT engaged enemy vic V-463559 in conjunction with attack of elements 141 RCT. During latter part of period, elements 141 RCT cleared town of FRAIZE against light resistance. 142 RCT, 1st Bn moved from BAN DE LAVELINE and seized WISEMBACH. 3rd Bn remained vic MANDRAY during early part of period, moving by motor to VERPELLIERE evening 24 Nov 44. Elements 143 RCT were engaged throughout period by enemy harassing detachment above LE CHIPA - La CROIX road.

25 November 1944

141 RCT established road block vic V-478554, cleared the town of SARUPT against slight resistance; effected inter-regimental reliefs during period. Elements 3rd Bn, 142 RCT, moving from WISEMBACH NE along ridge line, encountered a strongly held enemy road block vic V-553607, as balance of Bn approached STE MARIE AUX MINES from the N without contact. 141 RCT continued in enemy contact along CLEFCY - FRAIZE - SARUPT line, and Co L pushed to outskirts of PLAINFAING vic V-461527.

26 November 1944

During early part of period, 141 RCT relieved elements 143 RCT in LE CHIPA sector. 3rd Bn, 141 RCT attacked heights S of FRAIZE during latter part of period

and Co L advanced into PLAINFAING without opposition. 142 RCT, after reducing enemy road block vic V-603633, assaulted and captured the town of STL CROIX. STL MARIE AUX MINES was captured during the period and 140 PsW taken. 143 RCT assembled BAN DL LAVELING - STL CROIX.

27 November 1944

141 RCT sector remained relatively quiet with enemy movement noted in BONHOMM sector. 142 RCT cleared the towns of STLMB.CK and MUSLOCH against moderate resistance - prepared for attack on LTEPVRE. 143 RCT advancing towards RIBE.UVILLE established road block vic V-623587.

28 November 1944

142 RCT during early part of period cleared LTEPVRE without resistance and seized the high ground in vic V-7161 - elements 143 RCT seized hill mass at V-595548. Enemy activity increased in 141 RCT sector during the period and Sa fights were reported vic V-499528 and RJ at COL DE BONHOMME (V-5151). 3rd Bn, 142 RCT pushed towards KOENIGSBOURG Chateau vic V-7061, 2nd Bn met strong opposition in push toward La Vancelle (V-6765). 3rd Bn, 142 RCT reported on objective V-7061 at 2200. hours. 2nd Bn, 143 RCT (attached 142 RCT) moved by truck to vic LIEPVRE and attacked to the E from that point. Heavily defended road block encountered 1500 yards E of LIEPVRE. No advance during balance of period.

29 November 1944

Little enemy activity reported in 141 RCT sector during night 28-29 Nov. 141 RCT pushed toward objective line and reached V-510525, V-485525 and V-498527 without opposition. 2nd Bn, 143 RCT, operating in of LIEPVRE, breached enemy road block encountered previous night, captured 38PsW, and continued the advance. 142 RCT continued its attack towards ROMBACH and LA VANCELLE. 143 RCT maintained road blocks Sin of STE MARIE during period. 142 RCT secured NANGIGOUTTE and LA VANCELLE, taking 170 PsW.

30 November 1944

lst Bn, 142 RCT moved morning of 30 Nov by motor to vic KOLNIGSBOURG Chateau. 3rd Bn, 142 RCT from position at KOLNIGSBOURG Chateau moved at dawn towards CHATEN-OIS, and at close of period was engaged in fire fight at V-728618. 2nd Bn, 143 RCI operating with 142 RCT secured BOIS L'ABESSA and high ground in vic. During latter part of period 141 RCT assembled 1st Bn vic IA CROIX, 2nd Bn held line V-507526, V-499521, V-474528. Enemy still active in BONHOMME sector. 142 RCT cleared HURST (V-7064), reached the RJ at V-727668, and secured heights at V-7466. Combat patrol penetrated THANNANKIRCH (V-6759) and engaged small detachments of enemy in street fighting. 3rd Bn secured high ground overlooking CHATENOIS (V-7564) and cleared KIENTZHEIM.
